I have a clean-up going on in that area and groundwater is less than 100' for the most part. This well is actually in **31e**, which from what I can see, is going to be as you called it, 300'-400'. All of the other documents list 31e as the range, so if OK with you, I will just make a correction on the diagram. Until I get different directions, OCD would like to see a more complete delineation of spill sites, especially where contaminant levels are 5 digits and increasing with depth. Thanks - Mike
