

Describe Cause of Problem and Remedial Action Taken.* Approximately 53.8 bbls of produced water were released when a 3rd party contractor doing road work damaged the main water transfer line. Approximately 15 bbls volume recovered. The poly line has been repaired and an emergency response crew dispatched to remove surface contaminants.

Describe Area Affected and Cleanup Action Taken.* An area approximately 725 ft x 10 ft was impacted by the release with ~15 bbls of fluid recovered from the site. Soil samples will be collected from release area and submitted to Cardinal Laboratories for testing. Upon receipt of laboratory analytical data from soil samples collected during delineation operations, a Remediation Proposal will be prepared for approval.
