Cause of the release was due to a break in a water line. Line was isolated and shut in. Vacuum truck dispatched to recover standing fluid. Crews called in to repair line. Backhoe dispatched to excavate impacted area.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 12' X 100' was impacted. Impacted soils to be scraped up and taken to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX, Chlorides will be run for documentation. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted. **Depth to Ground Water: >100' (approximately 125', Section 25-T18S-R25E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**
