

Initially 5bbls of oil and 10bbls of produced water were released from a leak in the packing on the polishing rod. We were able to recover 0bbls with a												
vacuum truck. All free fluids have been recovered. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD/BLM for approval prior to any significant remediation work.
