

A piece of tubing that corroded due to age failed going to the intake side of the pump. The tubing has been replaced.

Describe Area Affected and Cleanup Action Taken.*

Initially 43bbls of produced water were released due a piece of tubing failed due to corrosion. We were able to recover 43bbls of produced water with a vacuum truck. The spill was contained inside the lined facility. All free fluid has been recovered. Any contaminated gravel has been removed, the liner has been steam cleaned and we has replaced with fresh gravel as necessary. This location has been returned to its prior condition.

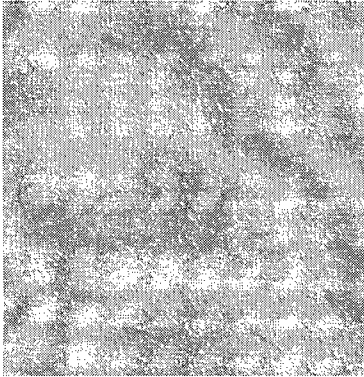
