A leak in a 4" poly production flow line caused 1 bbl of oil and 7 bbls of produced water to leak onto the ground. Free-standing fluids including 0.5 bbl of oil and 3 bbls of produced water were recovered via vacuum truck and the line was repaired.

Describe Area Affected and Cleanup Action Taken.\*

The affected area is approximately 30' x 900' on and off location. The leak is located approximately 1,000 feet North of the well head. Remediation will be completed in accordance with a plan approved by NMOCD.
