

Describe Cause of Problem and Remedial Action Taken.*: When I drove up to location at 10:27am I found well leaking from flowline. I shut in well and called Double R Trucking to pick up fluid off of the ground. Called Diversified to come and fix the poly line. Poly line blew a hole and the pressure kill switch failed to work.

Describe Area Affected and Cleanup Action Taken.*: Impacted area is about 24 foot by 24 foot in front of well head. North of the well was about 33foot by 27 foot square sprayed. We picked up 8barrels of fluid off the ground. 2barrels of oil and 6barrels of produced water.
