The tee coming off the backpressure valve was worn out and a hole was developed. The tee has been replaced.

Initially 7bbls of oil were released. We were able to recover 2bbls of oil with a vacuum truck. All free fluids have been recovered. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.

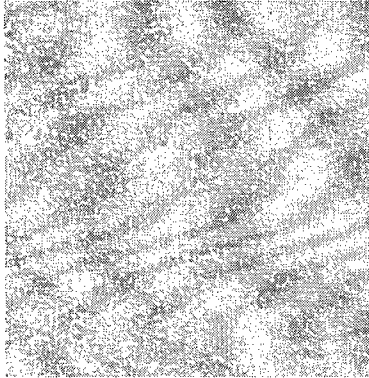
