

This is to inform you that Oxy Permian Primary NM South had a release at the Pure Gold D Federal #1 Battery on March 11, 2014. Oxy released 60 bbls of produced water due to a leak in a 3 inch poly water transfer line. A vacuum truck recovered a total of 57 bbls. The release is located in Section 28, T23S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: At NM 128, go South on Pure Gold Rd 0.7 mile, turn East and go 450 ft to battery, leak is 150 feet south of battery.
