A sight glass failed on a FWKO at the top connection. Sight glass has been replaced.

Initially 55bbls of oil released. We were able to recover 50bbls of oil with a vacuum truck. The spill was contained inside the lined facility. All free fluid has been recovered. Any contaminated gravel has been removed, the liner has been steam cleaned and we has replaced with fresh gravel as necessary. This location has been returned to its prior condition.

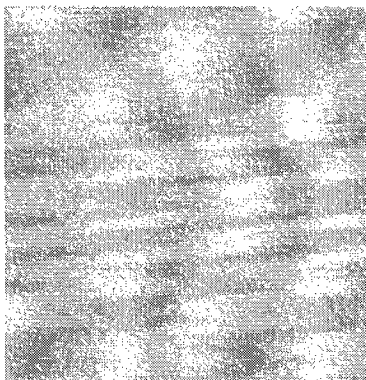
