

A 3" collar on the overflow water tank was inserted incorrectly and broke free. We installed a new collar and nipple on the water tank.					
Describe Area Affected and Cleanup Action Taken.*					
Initially 115bbls of produced water were released. We were able to recover 113bbls of produced water with a vacuum truck. The spill was contained inside the lined facility. All free fluid has been recovered. Any contaminated gravel has been removed, the liner has been steam cleaned and we has replaced with fresh gravel as necessary. This location has been returned to its prior condition.
