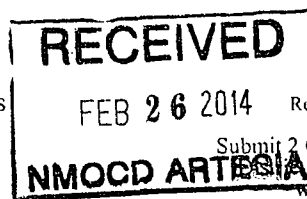

Isolation tool came off of well during recompletion work. The well was shut in/equipment shut down, vacuum truck(s) was called to the location.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 100' X 100'. Berms on location/battery contained water to pad area. Shut in well, recovered 92% of freshwater/starch, remaining soaked into pad, with being fresh water and modified starch, no further cleanup/remediation actions to be taken. **Depth to Ground Water: >100' (approximately 100', pre the ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on amounts released/recovered and being fresh water/starch, Yates Petroleum Corporation requests closure.**
