

Describe Cause of Problem and Remedial Action Taken.\*

The water transport truck appeared to have a clogged filter and screen on his trailer. The truck released fluids on the Resposado 2 State #2H location and pasture. The filter and screen have been cleaned and replaced. The trucking company is responsible for the release.

Describe Area Affected and Cleanup Action Taken.\*

Tetra Tech inspected site and collected samples to define spills extent. Soil that exceeded RRAL was removed and hauled away for proper disposal. Site was then brought up to surface grade with clean backfill material. Tetra Tech prepared closure report and submitted to NMOCD for review.
