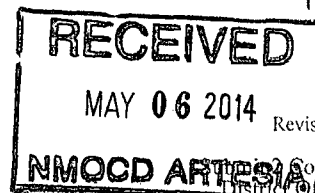

An approximate area of 169' X 64' was impacted within the bermed battery. The valve was shut off and vacuum trucks were called to clean up the spill. Impacted soils will be excavated and hauled to a NMOCD approved facility. Depth to Ground Water: >100' (approximately 360', Section 4, T20S-R24E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.
