Mr. Bratcher,

Linn Energy (Linn) has retained Diversified Field Service, Inc. (DFSI) to address environmental issues for the site detailed herein.

The site is located west of Maljamar NM, in Eddy County. The site resulted from a flow line leak due to corrosion of fittings around well head. The line rupture released fluids approximately 15 ft. Northwest off of location about 30 ft. long by 1ft wide. A form C-141 was submitted to the NMOCD on September 12, 2013.

Proposed Site Activities

DFSI personnel will scrape and clean the site area. Impacted soils will be removed to an NMOCD approved disposal facility. A soil sample will be submitted to a commercial laboratory for analyses. Fresh caliche will be hauled in, and the site will be leveled.

Conclusion

Upon completion of remediation activities in accordance with NMOCD and BLM requirements, DFSI will submit a request to close the regulatory file for the site.
