

Describe Cause of Problem and Remedial Action Taken.* The crude oil tank spill over valve failed to equalize and disperse volume to the other tanks, causing the release. Wells were shut in and vacuum trucks were called to remove the standing fluid.		
Describe Area Affected and Cleanup Action Taken.* An approximate area of 120' X 15' was affected within the bermed battery. Vacuum trucks were called to remove standing fluid, and impacted soil will be removed and taken to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. Depth to Ground Water: >100' (approximately 105', Section 17, T19S-R25E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.
