

4.5 BBLS of the 5BBLS oil lost were recovered by Arapahoe Trucking by vacuum truck on May 8, 2014. The spill originated on the SE side of the well pad inside containment. The dike had a hole in it allowing approximately 80% of the spilled fluid to escape containment. Soil samples have been taken for testing


