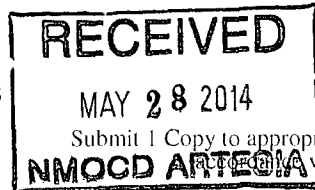

Describe Cause of Problem and Remedial Action Taken.*

The suction hose parted on mud pump #1 causing approximately 80 bbls of cut brine mud to spill on the ground around the mud pumps and pit. Crews were cleaning up the spill around the pump getting everything into the ditches that they can so that it can be sucked up.

Describe Area Affected and Cleanup Action Taken.*

The spill was contained on location with most of it caught in the secondary containment ditches around the pump. The area will be addressed when the rig moves off location.
