
Describe Cause of Problem and Remedial Action Taken.*

The valve was left open at the unloading port, causing the release onto the driveway pad. The valve was shut off; vacuum truck(s) and excavation crew called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 60' X 60'. Excavated soils will be hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: > 100' (approximately 125' per the Chevron/Texaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 0.**
