

If a Watercourse was Impacted, Describe Fully.*

Describe Cause of Problem and Remedial Action Taken.* A pipe connection on the back of the water tank broke for reasons unknown. The 2" valve between the tank and the pump was closed, stopping the flow of water. The connection was later replaced.

Describe Area Affected and Cleanup Action Taken.* The released fluid affected an area of approximately 2,000 sq. ft inside the earthen containment around the tanks. The facility did not have impervious containment at the time. The free-standing fluids were removed with a vacuum truck. Following initial response activities, the release was remediated per NMOCD guidelines in conjunction with a release that occurred on 5/13/10 and affected the same area. Please reference the attached *Remediation Summary & Risk-Based Site Closure Request* for details of remediation activities and laboratory analytical results from confirmation soil samples.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases, which may endanger public health or the environment.
