

Describe Cause of Problem and Remedial Action Taken.* On Monday, 03/24/2014 @ ~0600 hrs. MST at the Skaggs B-12, an accidental discharge of ~26 BPW occurred. While checking wells, a COPC employee discovered a leak coming from a valve box at the Skaggs B-12 location. Inside the valve box, the dresser sleeve was leaking fluids. The leak was contained inside a fully contained valve box with the exception of 1 BPW over flow that spilled to ground. The well was shut in and a vacuum truck was contacted. Vacuum Truck recovered 25 BPW; NMOCD was contacted via phone call. The spill site will be remediated according to NMOCD guidelines.		
Describe Area Affected and Cleanup Action Taken.*
