A failure of the circulating pump caused the release of oil. All fluid was contained within the bermed area. A vacuum truck was dispatched to removal all standing fluids.

Describe Area Affected and Cleanup Action Taken.*

The impacted area was to the south of the tanks inside the containment. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCDC for approval prior to any significant remediation work.
