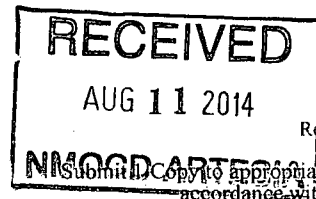

Describe Cause of Problem and Remedial Action Taken.* Lightning struck the SWD facility (fiberglass produced water tank), causing the release and fire. Fire Department and vacuum truck(s) called.		
Describe Area Affected and Cleanup Action Taken.* An approximate area of 125' X 200' was affected. The spill was contained within the battery; after fire was extinguished vacuum trucks were called to recover produced water and water from fire trucks. Upon removal of equipment destroyed by lightning strike/fire, impacted soils will be excavated/hailed to a NMOCD approved facility. Vertical/horizontal delineation samples will be taken and analysis ran for TPH/BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 10) a Final Report, C-141 will be submitted to the NMOCD requesting closure. If results are above the RRAL's a work plan will be submitted to the NMOCD. Depth to Ground Water: 50-99' (approximately 75', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10.
