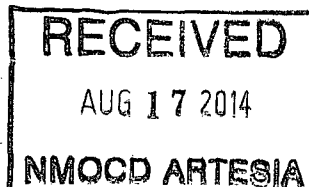

A split in the polyline caused the release of produced water. The polyline was fused back together and a vacuum truck dispatched to pick up any standing fluids and dispose of at an NMOCD approved facility.

Describe Area Affected and Cleanup Action Taken.\*

The impacted area was approximately 27' x 300' along the road. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
