

A water transfer line south of the berm ruptured due to pressure.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 20' X 350' (release occurred outside of the unlined bermed battery south of the tanks). All wells were turned off, tank valves were shut, personnel ensured that no leaks continued and the line was repaired. A crew will be called to do initial clean-up of the area, and all excavated soils will be disposed of at an approved NMOCD facility. Vertical and horizontal delineation samples will be taken and sent to a NMOCD approved facility. **Depth to Ground Water: >100' (approximately 150', Section 11, T22S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.** Yates Petroleum requests closure based on work being completed as approved by both NMOCD and BLM from a work plan submitted to both agencies on February 25, 2014. All analytical reports and site diagram of release area were submitted to both agencies in the work plan. The release area was re-seeded with BLM LPC Seed mix on 7/30/2014. No further work is needed at this site.
