Describe Cause of Problem and Remedial Action Taken.* According to our limited records, There was a small produced water leak from a poly line. CRA went out and collected soil samples and the north wall near a pipeline ROW had elevated chlorides concentrations. Area is on north side of lease road between Madera Ridge 25 #1 and Vaca Lane.		
Describe Area Affected and Cleanup Action Taken.* The site is currently excavated with the stockpiled soil sitting on poly plastic. CRA recommended that we submit the figure and this C-141 and ask for guidance and see if we could backfill with clean soil to grade and dispose of stockpile to Sundance Landfill.
