Describe Cause of Problem and Remedial Action Taken.* Cause of the leak- SWD pump was down due to electrical problem (blown fuse) and a valve was also left open on unloading station. Pumper shut valve upon arrival to stop leak and electrician fixed blown line fuse to get pump back online.		
Describe Area Affected and Cleanup Action Taken.* Affected area- Secondary containment and southwest side of well pad surface (entire pad has 2' earth berm). Vacuum truck moved in and recovered all standing fluid inside the secondary containment and on the bermed pad surface. Contaminated soil on pad surface will be removed and hauled to an approved NMOCD disposal site.
