The tank water leg and valve busted due to flood waters that occurred during heavy rains. Valves were shut, vacuum truck(s) and roustabout crew called.

An approximate area of 68 x 20 feet was affected within the bermed battery, with an additional area of 315 x 130 affected outside of the bermed battery to the east and another finger approximately 480 x 80 feet running north off the wide release area. The water valves and water leg were repaired. Vacuum trucks were called to recover any standing fluid. Excavated soils will be hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. **Depth to Ground Water: >100' (approximately 245', Section 4, T20S-R24E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS ZERO (0).**
