Livestock tampered with and opened the 1" bleed valve on the well head spilling 6 bbls of oil and 6 bbls of produced water on to the ground. The valve was closed and a plug was installed.

The affected area is approximately 40' x 100' on location. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.

Subject: Lost Tank 3 Federal #15

This is to inform you that Oxy Permian Primary NM South had a leak at the Lost Tank 3 Federal #15 on September 15, 2014. Oxy spilled 6 bbls oil and 6 bbls produced water due to livestock tampering and opening the 1" bleed valve on the wellhead. The preliminary report shows the leak measuring approximately 40' x 100' with all of the leak staying on location. No fluids were recovered. The release is located in U/L E, Section 3, T22S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From US 62/180, go to MM65, turn South on Whipp Rd to 1.5 miles past mile marker 6, turn left on lease road and go 1 mile, turn left 0.5 mile, turn left 0.5 mile again, and dead end on location.
