

Describe Cause of Problem and Remedial Action Taken.*

Human error. The battery was down for repair due to a pump failure with a well watcher on site to maintain well. Vacuum truck trucks were dispatched to remove all standing fluid.

Describe Area Affected and Cleanup Action Taken.*

The majority of the impact was contained within the lined facility. Approximately 225'x100' was impacted outside the containment. All standing fluids were picked up and disposed of at an NMOCD approved facility. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
