

Describe Cause of Problem and Remedial Action Taken.*

A leak in the Halliburton meter caused the release. Water line and valves were closed; vacuum truck(s) and roustabout crew called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 50 X 50'. Vacuum trucks were called to retrieve standing fluid and a roustabout crew repaired Halliburton meter. Excavated soils will be hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 228', Section 3, T20S-R24E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**
