I am sorry I have been hard to get a hold of I am in Alabama this week. The nationwide permit you will need is NWP 20 for oil and gas cleanup. As long as the draw you are impacting is ephemeral in nature you do not have to report to the Corps of engineers to do that work. It is considered a permissive permit or a no reporting permit, as long as the draw is ephemeral you can just go out and do what you need to do. If you require a letter from the Corps you just need to fill out our application form and send in the supporting documentation but understand if your draw is ephemeral you can just go out and do what you need to do under the NWP 20.

Out of caution I would rather pursue the necessary permits, and have them in place, in case we are forced to remove and replace soil. Am I correct in assuming that we can't conduct any dirt work at the sight until we have the necessary permits in hand?

At this point Agave Energy will be handling the cleanup. We will most likely excavate and remove contaminated soil and replace it with clean soil. We will look at remediating in place but that will depend on the sampling results, which we anticipate having back by the end of the week. Agave has contacted Souder, Miller and Associates to assist in acquiring any necessary permits, on our behalf, from the Corps of Engineers and any other applicable agencies.

I am Lucas Middleton from Souder Miller & Associates on behalf of Agave Energy Company. I am reporting a discovery of a historic spill.

The spill was discovered on 11/14/14 on a right-of-way for a natural gas pipeline that has been decommissioned.

The historical spill is located is next to 4- Mile Draw (See Figure 1).

The location of the area is T19S R24E Section 12.

The draw connects downstream to Lake McMillian (Figure2) which is a nexus for the water of the US.

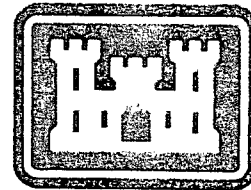
