Ike,

I will be managing this spill event for the BLM, so please send further correspondence to me also. The plan is approved with sidewall closure samples taken and evaluated prior to back-filling. I will also need a copy of the vertical delineation that you supply the OCD with. I am a little concerned that the sample results show a large difference in chlorides.

Basically, the area needs to be cleaned to back ground or to 3'. A liner or 9"-12" clay bottom are both accepted practices. If chlorides are deeper, the OCD may want to remove more since the well is in an area with shallower groundwater, but with the clay bottom or liner, the chlorides should not be able to be driven down further.

The hillside to the south shall not be disturbed.
