
Describe Cause of Problem and Remedial Action Taken.*

The pumping unit packing blew out, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 20' X 20'. Problems with the packing were corrected and vacuum trucks were called, recovering the most of the released fluid (1 B/O & 2 B/PW). Impacted soils excavated /hauled to a NMOCD approved facility. Depth to Ground Water: 50-99' (approximately 70', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on majority of released oil/produced water recovered and all impacted soils excavated and hauled to an NMOCD approved facility, Yates Petroleum corporation requests closure.
