There was a hole in the bottom of the production unit, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 130' X 30' within the lined/bermed battery. Wells were shut off, the production tank was repaired and remaining oil was recovered using a vacuum truck (34 B/O). Impacted gravel to be excavated/hailed to a NMOCD approved facility. Depth to Ground Water: > 100' (approximately 225', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on the battery being lined/bermed, 97% of the released crude oil recovered; Yates Petroleum Corporation requests closure.
