Pursuant to Division Rule 19.15.15.11, Cimarex Energy Company of Colorado ("Cimarex") respectfully requests administrative approval for a 720-Acre Non-Standard Spacing Unit/Horizontal Project Area in the Benson-Bone Spring Pool (5200) comprising the N/2 NE/4 & NE/4 NW/4 of Section 23 and the S/2, NE/4, S/2 NW/4 and NE/4 NW/4 of Section 14, both in Township 19 South, Range 30 East, NMPM, Eddy County, New Mexico.

The proposed spacing unit/horizontal project area is to be dedicated to the following-described existing wells:

1. **Irwin 23 14 Federal No. 1** (API No. 30-015-39891) located as follows:
Surface Location: 1300' FNL & 695' FEL (Unit A) Section 23
FTP: 984' FNL & 711' FEL (Unit A) of Section 23
BHL: 344' FNL & 694' FEL (Unit A) of Section 14
2. **Irwin 23 14 Federal No. 2** (API No. 30-015-39892) located as follows:
Surface Location: 1300' FNL & 725' FEL (Unit A) of Section 23
FTP: 741' FNL & 929' FEL (Unit A) of Section 23
BHL: 341' FNL & 2307' FWL (Unit C) of Section 14
3. **Irwin 23 14 Federal No. 3H** (API No. 30-015-39893) located as follows:
Surface Location: 1300' FNL & 755' FEL (Unit A) of Section 23
FTP: 505' FNL & 1480' FEL (Unit B) of Section 23
LTP: 1698' FNL & 351' FWL (Unit E) of Section 23
BHL: 1647' FNL & 333' FWL (Unit E) of Section 14

4. Irwin 23 14 Federal No. 4H (API No. 30-015-39894) located as follows:
Surface Location: 1300' FNL & 785' FEL (Unit A) of Section 23
FTP: 700' FNL & 1774' FEL (Unit B) of Section 23
BHL: 1087' FSL & 411' FWL (Unit M) of Section 14

The Irwin 23 14 Federal No. 1 was drilled and completed in the Benson-Bone Spring Pool in March, 2012. At the time the well was drilled, Cimarex submitted a Form C-102 to the Artesia District Office of the Division ("Artesia OCD") showing the horizontal project area for the well to comprise the N/2 NE/4 & NE/4 NW/4 of Section 23 and the S/2, NE/4, S/2 NW/4 and NE/4 NW/4 of Section 14, both in Township 19 South, Range 30 East, NMPM, Eddy County, New Mexico. At that time, the Artesia OCD did not require Cimarex to obtain an order approving a non-standard spacing unit/horizontal project area for this well.

The Irwin 23 14 Federal No. 2 was drilled and completed in the Benson-Bone Spring Pool in June, 2012. A Form C-102 submitted to the Artesia OCD showed this well to be dedicated to the same 720-acre horizontal project area that was dedicated to the Irwin 23 14 Federal No. 1.

The Irwin 23 14 Federal No. 3H was drilled and completed in the Benson-Bone Spring Pool in December 2012. A Form C-102 submitted to the Artesia OCD showed this well to be dedicated to the same 720-acre horizontal project area that was dedicated to the Irwin 23 14 Federal Wells No. 1 & 2. Subsequently, Cimarex obtained Order No. NSL-6855 dated September 11, 2013 which order approved an unorthodox FTP and bottomhole location for this well. Pursuant to Order No. NSL-6855, the horizontal project area dedicated to the Irwin 23 14 Federal No. 3H consisted of 280-acres and comprised the SW/4 NW/4, N/2 SW/4, SE/4 SW/4 & SW/4 SE/4 of Section 14, and the N/2 NE/4 of Section 23.

The Irwin 23 14 Federal No. 4H was drilled and completed in the Benson-Bone Spring Pool in March, 2013. A Form C-102 submitted to the Artesia OCD showed this well to be dedicated to the same 720-acre horizontal project area that was dedicated to the Irwin 23 14 Federal Wells No. 1, 2 and 3H.

An examination of the directional survey for the Irwin 23 14 Federal No. 3H indicates that the well is located at standard FTP and LTP locations within the proposed 720-acre non-standard spacing unit/horizontal project area.

Cimarex requests approval of the proposed 720-acre non-standard spacing unit/horizontal project area, and in support thereof states that:

1. An examination of the directional surveys for the Irwin 23 14 Federal Wells No. 1, 2, 3H and 4H indicates that all wells are at standard FTP, LTP and/or BHL locations within the proposed 720-acre non-standard spacing unit/horizontal project area; and,
2. The Irwin 23 14 Federal Wells No. 1, 2, 3H and 4H will adequately drain and develop the proposed 720-acre non-standard spacing unit/horizontal project area in the Benson-Bone Spring Pool.

The proposed 720-acre non-standard spacing unit/horizontal project area excludes the NW/4 NW/4 of Section 23 and the NW/4 NW/4 of Section 14. Pursuant to Division rules, notice of this application is required to be furnished to the leasehold owners of the tracts being excluded from the proposed non-standard spacing unit/horizontal project area. Cimarex is the Bone Spring leasehold owner within the NW/4 NW/4 of Section 14. In addition, the interest ownership between the NW/4 NW/4 of Section 14 and the proposed 720-acre non-standard spacing unit/horizontal project area is common. Consequently, notice of this application is not required as to the NW/4 NW/4 of Section 14. The Bone Spring leasehold owner within the NW/4 NW/4 of Section 23 is ExxonMobil Corporation. In accordance with Division rules, ExxonMobil Corporation will be provided notice of this application.

Attached is a Form C-102 for each of the Irwin 23 14 Federal Wells No. 1, 2, 3H and 4H showing the surface and bottomhole well locations and proposed non-standard spacing unit/horizontal project area. Also attached is a map showing the subject wells, proposed non-standard spacing unit/horizontal project area, and affected offset tracts.

In summary, approval of the application will provide Cimarex the opportunity to recover additional oil and gas reserves from the Benson-Bone Spring Pool underlying the N/2 NE/4 & NE/4 NW/4 of Section 23 and the S/2, NE/4, S/2 NW/4 and NE/4 NW/4 of Section 14, both in Township 19 South, Range 30 East, NMPM, Eddy County, New Mexico, that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.

You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide Rule 15.9.A [19.15.15.9.A NMAC], which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary, and Rule 15.16.14.B(2) [19.15.16.14.B(2) NMAC] concerning directional wells in designated project areas. This location is unorthodox because portions of the proposed completed interval are less than 330 feet from outer boundaries of the project area.

It is our understanding that you are seeking this location due to United States Bureau of Land Management requirements for drilling in the Potash Area.


It is also understood that notice of this application to operators or owners of adjoining units is unnecessary due to common ownership.
