

Hole developed in heater treater. Vacuum truck(s) and roustabout crew(s) called.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 50' X 20' was affected within the lined/bermed battery. Remaining oil/produced water was moved to a tank at the battery, valves shut, heater repaired. Vacuum trucks recovered 95% of released oil and produced water, remaining oil/produced water entrained in impacted gravel, gravel was taken to an approved facility of disposal. **Depth to Ground Water: 50-99' (approx. 50', ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on battery being lined/bermed and 95% of crude oil/produced water was recovered, Yates Petroleum Corporation requests closure.**
