Describe Cause of Problem and Remedial Action Taken.*

A gasket failed on the heater-treater fire tube. The heater was by-passed and the gasket was replaced.

Describe Area Affected and Cleanup Action Taken.*

The spill impacted approximately 2100 sq. ft. of tank battery caliche containment area and approximately 250 sq. ft. of pasture was misted with crude oil. There was no vegetation in the pasture area impacted. A vacuum truck recovered the free standing fluids. The stained area was left as is pending the final remediation.

The area will be cleaned up in accordance with the NMOCD and BLM remediation guidelines.
