This release was caused when a pulling unit crew left a hold down pin loose in the wellhead and it caused a blowout. Crews reinstalled the pin and was able to stop the blow out.

Describe Area Affected and Cleanup Action Taken.\*

The affected was the pad and the pasture to the southwest and northeast corner of the pad. The impact was a light mist. Crews scraped the pad and microblazed the pasture. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
