The stuffing box leaked, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 20' X 20'. Problems with the stuffing box were corrected and vacuum trucks were called, recovering most of the released fluid (2 B/O & 1 B/PW). Impacted soils excavated /hailed to a NMOCD approved facility. **Depth to Ground Water: 50-99' (approximately 70', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on the volumes released/recovered fluid recovered and impacted soils excavated/hailed for disposal, Yates Petroleum Corporation requests closure.**
