Joshua and Pat,

I inspected the Schley Federal 11 flowline spill yesterday and mapped the visible salts from the spill point downslope. The spill is larger than indicated on your spill report. Fluids ran down the road to the Empire Abo Unit 50, then followed drainage off the western edge of that pad to the south, then southeast. I tracked the spill/salts down to an older spill in the flowline corridor about 200 feet northwest of the Green A Federal 10 SWD unit. At this point, it appeared that your spill overran and/or comingled with an older spill. I do not know whose flowline the older spill belongs to.

I am attaching a spill map of the spill as I GPS'd it yesterday.

All of the spill path area is covered by pre-existing archeological surveys, so it is okay to proceed with cleanup. However, the older spill complicates things somewhat.
