
Describe Cause of Problem and Remedial Action Taken.*

4" Poly connection on a flowline between two wells started to leak due to corrosion. Vacuum trucks were dispatched to the standing fluid and repairs were made.

Describe Area Affected and Cleanup Action Taken.*

The impacted area is approximately 40' x 20' in the pasture. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
