

HIGH OXYGEN CONTENT WAS THE CAUSE FOR THE FIRST 10 MINUTES, WHEN OXYGEN CONTENT DROPPED BELOW FLARE LIMIT, FLARE VALVE LOCATED AT KINDER MORGAN DIDN'T CLOSE. FLARED FOR 41 MINUTES DUE TO FLARE CONTROL FAILURE. Remedial Action Taken: OXYGEN FLARE EVENT LASTED 10 MINUTES, DUE TO SHORT DURATION OF EVENT, SOURCE OF OXGEN COULDN'T BE DETERMINED. KINDER MORGAN HAD A FLARE CONTOL FAILURE FOR THE REMAINING 41 MINUTES, WHICH KINDER MORGAN HAD TO RESPOND TO MANUALLY CLOSE THE FLARE VALVE.
