This e-mail is to confirm our discussion on September 5, 2012 concerning the remediation plan for the release that occurred at the Oxy MH Fed Com #1 N SWD. As agreed, Oxy will excavate to a depth of 1 foot across the entire spill area as depicted on the attached site diagram. The excavation will then be backfilled with clean soil. The depth to groundwater in this area is approximately 50 feet.

I have attached the site drawing and the summary of the laboratory data we reviewed during our discussion for your files. If you would please reply back via e-mail with your concurrence of this remediation plan, it would be greatly appreciated.
