Describe Cause of Problem and Remedial Action Taken.* Upon arriving to lease, I made my rounds to Satellite #3, and discovered crude oil and production water coming out from flare stack. After discovering the spill I checked the area and found both transfer pumps were down on power. I tried resetting the pumps manually but was unable to do so successfully. I called D&C Electric to check panel boxes and fuses. They found that CVE had a fuse down on the main line causing power failure. I redirected the fluid to go down bypass and waited for the repairs to be done. The issue was fixed and was able to turn on transfer pumps.		
Describe Area Affected and Cleanup Action Taken.* Called vacuum truck and sucked up free standing fluid, and called backhoe to clean up the remaining spill.
