
Describe Cause of Problem and Remedial Action Taken.*

The circulating pump leaked, causing the release. The pump was turned off and repairs made to the pump.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 35'X 20' was affected within the lined/bermed battery. The circulating pump was turned off and the suction and discharge were closed on the pump. The impacted gravel (including the 7 B/O) was excavated /hauled to a NMOCD approved facility. Depth to Ground Water: 50-90' (approximately 65', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on the battery being lined/bermed and all released oil removed with impacted gravel, Yates Petroleum Corporation requests closure.
