Describe Cause of Problem and Remedial Action Taken.*

There was a hole in the production tank, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 30' X 20' was affected within the lined/bermed battery. The tank was isolated and the valves were closed. A vacuum truck recovered approximately 83% (10 B/O) of the released crude oil and repairs were made to the production tank. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the NMOCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the NMOCD. **Depth to Ground Water: > 100' (approximately 250', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**
