I need to make a correction to this C-141.

Apparently after gauging the tank and looking at water haul tickets, it was realized that the total volume of water released was 160 bbls. We did only recover 20 bbls and this is a lined facility. When the dirt covering was removed from the liner two (2) rips were discovered. That would make total volume lost 140 bbls of produced water.

This is an active production facility. Please advise as to how you'd like us to move forward.
