Dear Mr. Catanach:

EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Lucky 13 Fed Com No. 5H Well** (API number pending) to be completed within the Red Hills; Upper Bone Spring Shale Pool (Pool Code 97900) underlying Sections 12 and 13, Township 25 South, Range 33 East, N.M.P.M., Lea County, New Mexico. The **Lucky 13 Fed Com No. 5H Well** will be an infill well for a non-standard project area previously approved by the Oil Conservation Division. See NSP-2033. This well will be drilled from a surface location 2315 feet from the South line and 2387 feet from the West line (Unit K) of Section 13. The upper most perforation will be located 2589 feet from North line and 2623 feet from the West line (Unit F) of Section 13 and the lower most perforation will be 1650 feet from the North line and 2621 feet from the West line of Section 12 (Unit F). Since this acreage is governed by the Division's statewide rules which provides for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the eastern, southern, and southeastern boundaries of the project area. Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

As support for this application, EOG provides the following additional information and exhibits:

Exhibit A is the Well Location and Acreage Dedication Plat (Form C-102), which shows the proposed non-standard location of the **Lucky 13 Fed Com No. 5H Well**.



Exhibit B is a land plat for Sections 12 and 13 and the surrounding sections that shows the **Lucky 13 Fed Com No. 5H Well** in relation to the adjoining units and existing wells.

Exhibit C is a list of the parties affected by EOG's request for an unorthodox location. Each of these parties has been provided a copy of this application and all attachments by certified mail, and has been advised that if they have an objection it must be filed in writing with the division within 20 days from the date the division receives this application. In addition, a courtesy copy of this application has been provided to the Bureau of Land Management-Carlsbad.

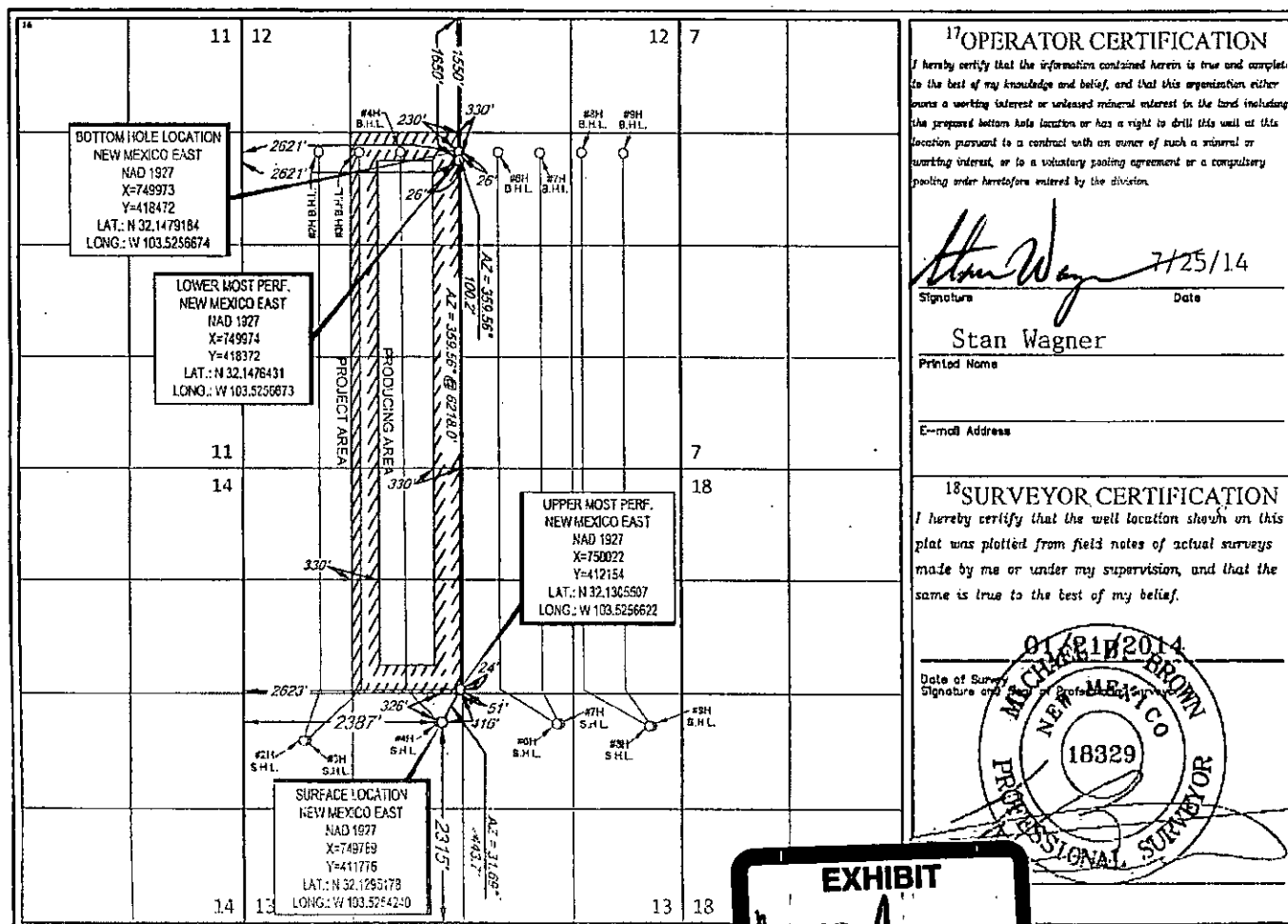
