

Describe Cause of Problem and Remedial Action Taken.*

The valve on the circulating line was left open to the wrong tank spilling 133 bbls of oil onto the ground. A vacuum truck recovered 110 bbls and the valve was closed.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately 75' x 50' on location within the containment area. Remediation will be completed in accordance with a remediation plan approved by both NMOCD and the BLM.

This is to inform you that Oxy Permian had a leak at the Sundance 10 Federal #1 CTB on August 10, 2015. Oxy spilled 133 bbls of oil due to the valve on a circulating line being left opened to wrong tank. The preliminary report shows the leak measuring approximately 75' x 50' on location inside the berm. A vacuum truck recovered 110 bbls of fluids. The release is located in U/L D of Section 10, T24S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From Carlsbad, go south on the Loving Hwy to NM31, turn east and go 12 miles to NM128, turn south and go 14 miles to Pure Gold Rd, turn right and go 2 miles, turn left at Sundance A CTB and go 0.5 mile, turn right at the windmill and go 0.5 mile to big white Chevron sign, turn east and go 1 mile to battery on the left side of the road.
